Principal and Academic Committee members evaluate effectiveness of teaching methods framed by the IQAC. The academic implementation monitored by the IQAC as follows:

- Allocation of subjects and Preparation of Time Table before the commencement of Academic year.
- 2. All the faculty members submit their lesson plans for conducting the theoretical classes to the Academic Committee.
- The lessons plans are verified in accordance with the syllabus of the Karnataka State Law University.
- 4. All faculty members maintain teaching lesson diaries maintain regularly.
- The lesson plans and teaching diaries periodically monitored by the Principal and Academic Committee.
- The Academic Committee decides to prepare the time table to conduct the Internal Assessment Tests as per the syllabus.
- Clinical Courses of internal examinations are conducted by the Course teacher as the KSLU syllabus.
- 8. At the end of semester, if the syllabus could not be covered as per the schedule the teachers take extra classes to cover the syllabus.
- 9. The Head of the institution also reviews the various academic activities.
- 10. The Head of the Institution holds the faculty meeting and guides the faculty members.
